

JIM LEA CHARITY CLOTHES / STAGE CLOTHES AUCTION – SUMMER 2020 – RULES AND REGULATIONS

PURPOSE

THIS IS A CHARITY AUCTION RUN BY JIMLEAMUSIC.COM TO SELL CLOTHES AND STAGE CLOTHES OWNED BY JIM LEA (PREVIOUSLY OF SLADE).

JIM WANTS TO RAISE FUNDS FOR HIS NOMINATED CHARITY TOGETHER WITH PASSING ON CLOTHES TO FANS WHO HAVE SUPPORTED HIM AND SLADE OVER THE YEARS. PROFESSIONAL BUYERS OF MEMORABILIA – WHO PURCHASE ITEMS PURELY FOR RESALE – WILL BE EXCLUDED FROM THE AUCTION.

BENEFICIARY OF AUCTION

THE AUCTION IS TO BENEFIT A LOCAL DEMENTIA CHARITY CLOSE TO WHERE JIM LEA LIVES

AUCTION DETAILS

THE AUCTION WILL RUN OVER THE PERIOD OF THE SUMMER, AND POSSIBLY THE AUTUMN, OF 2020.

THERE ARE APPROXIMATELY TWENTY LOTS THAT WILL BE SOLD DURING THE AUCTION.

LOTS WILL BE SOLD RANDOMLY – WITH ONE, TWO OR MORE LOTS SOLD AT THE SAME TIME.

EACH LOT FOR AUCTION WILL BE SHOWN / ADVERTISED ON THE WEBSITE WWW.JIMLEAMUSIC.COM

BID DETAILS

BIDS WILL BE TAKEN ON EACH LOT FOR A PERIOD OF SEVEN DAYS

BIDS NEED TO BE MADE IN GBP (GREAT BRITISH POUNDS STERLING)

BIDS NEED TO BE MADE BY CLOSED EMAIL TO THE FOLLOWING EMAIL ADDRESS: jimleaclothesauction@gmail.com

EACH BID NEEDS TO CONTAIN THE LOT NUMBER AND THE AMOUNT OF THE BID IN THE TITLE. For example: **LOT ONE – BID £ xxx**

IN THE CONTENT OF THE EMAIL THE BIDDER SHOULD INCLUDE THE FOLLOWING INFORMATION: THE BIDDERS NAME AND FULL ADDRESS, THEIR CONTACT PHONE NUMBER AND THE REASON THEY WOULD LIKE TO OWN THE ITEM, AND WHAT THEY INTEND PURCHASING IT FOR. For example: **“I HAVE BEEN A FAN OF SLADE FOR 45 YEARS, AND I HAVE COLLECTED ALL THEIR RECORDS – THIS WOULD BE A GREAT ADDITION TO MY COLLECTION OF MEMORABILIA I DISPLAY AT HOME”** etc

ALL BIDS ARE ‘BLIND’ – THEY WILL NOT BE PUBLISHED ON THE WEBSITE. NO RUNNING TOTAL OF THE HIGHEST BIDS WILL BE DETAILED.

WINNING BIDS

ONCE THE AUCTION HAS CLOSED, ALL EMAIL BIDS WILL BE VIEWED, LISTED AND DISCUSSED BY THE ‘AUCTION PANEL’ OF JIM LEA AND HIS MANAGER FRANK LEA.

THE ‘AUCTION PANEL’ WILL CONSIDER ALL BIDS ON THE BASIS OF THE AMOUNT OF THE BID TOGETHER WITH THE REASON FOR THE BIDDER WANTING TO OWN THE ITEM AND WHAT THEY INTEND PURCHASING IT FOR.

THE WINNING BID FOR EACH LOT THEREFORE WILL NOT NECESSARILY BE THE HIGHEST MONETARY BID.

THE DECISION MADE BY THE ‘AUCTION PANEL’ ON WHO WINS EACH LOT IS FINAL.

THE WINNER OF EACH LOT WILL BE NOTIFIED EITHER BY PHONE CALL OR EMAIL WITHIN TWO DAYS OF EACH INDIVIDUAL AUCTION FINISHING.

PAYMENT

PAYMENT FOR ALL LOTS HAS TO BE MADE IN FULL WITHIN TWO DAYS OF THE WINNER RECEIVING NOTIFICATION. IF NOT THE LOT WILL BE AVAILABLE TO

PURCHASE BY ANOTHER BIDDER DECIDED BY THE 'AUCTION PANEL'. PAYMENT FOR ALL ITEMS HAS TO BE MADE BY BANK TRANSFER OR PAYPAL **ONLY**.

DISPATCH OF WINNING ITEMS

THE METHOD OF DISPATCH OF THE WINNING ITEMS WILL BE DISCUSSED DIRECTLY WITH THE WINNER.

HOWEVER, THE PREFERRED METHOD IS BY **PERSONAL COLLECTION** FROM THE CAMBRIDGESHIRE AREA (DETAILS PROVIDED TO THE WINNERS).

ALTERNATIVELY, WE WOULD ENCOURAGE COLLECTION BY A COURIER ARRANGED BY THE PURCHASER. HOWEVER, OTHER OPTIONS OF PARCEL POSTAGE ARE AVAILABLE AND WILL BE DISCUSSED WITH WINNERS. ALL POSTAGE COSTS ARE TO BE COVERED BY THE LOT WINNERS.

GENERAL

THE ORGANISERS OF THE AUCTION HAVE TRIED THEIR BEST TO DESCRIBE ALL ITEMS ACCURATELY AND PROVIDE CLEAR PHOTOS. HOWEVER, THEY WILL NOT BE RESPONSIBLE FOR NOT DESCRIBING ANY BLEMISHES OR DAMAGES TO THE CLOTHES NOT SHOWN. PLEASE REALISE THAT CLOTHING ITEMS ARE SOMETIMES 45+ YEARS OLD, AND NOW DELICATE AND MAINLY ARE VERY SMALL SIZE – NOT REALLY FIT TO BE WORN BY MOST ADULTS.

ALL AUCTION ITEMS CAN BE WITHDRAWN AT SHORT NOTICE

THE RULES / CONDITIONS/ TERMS OF THE AUCTION CAN BE CHANGED AT ANY TIME WITHOUT NOTICE.

THE AUCTION CAN CLOSE IMMEDIATELY WITHOUT PRIOR WARNING – WITHOUT ALL ITEMS BEING SOLD

THE 'AUCTION PANEL' CAN DECIDE NOT TO ACCEPT BIDS FROM ANY INDIVIDUAL OF THEIR CHOICE WITHOUT GIVING REASON.

THE WINNERS OF EACH LOT AND THE WINNING BID AMOUNTS WILL NOT BE DETAILED OR PUBLISHED.
